Rationale

As a school we believe that musical activity provides children with the opportunity to explore feelings and express themselves in ways that support or go beyond verbal communication. It is a powerful, unique form of expression that can change the way pupils feel, think and act. Music provides a context for developing creativity, self-confidence and self-esteem through the key activities of making and responding to music. Music helps children to learn to listen, to distinguish between sounds and to respond to pulse and rhythm. These are extremely elements in children's overall development.

Music Leadership

Music is under the leadership of the Creativity Team. The team's leader is Mrs. I. McClurg. Within the Creativity Team Miss Carson and Miss Hasson have responsibility for Music. This involves the following key roles:

- Drafting and reviewing the policy every two years.
- Supporting colleagues in the implementation and development of the Music curriculum.
- Organising the storage of equipment and maintaining and replacing as necessary.
- Monitoring the planning and teaching of the subject to ensure standards remain high in each year group.
- Attending meetings and courses which will inform future development of the subject and ensuring all teachers are aware of courses themselves.
- Ensuring that pupils have the opportunity to become involved in extra curricular activities to further develop skills and talents.
- Providing the Creativity Team Leader with evaluations which highlight strengths and weaknesses in the subject and suggest areas for improvement.

Aims

Through the teaching of music pupils will be enabled to:

- 1. Work creatively with sound by creating musical stories, pictures, patterns, conversations, accompaniments and by investigating ways of preserving the music they have created.
- 2. Sing and perform with simple instruments from memory, by ear or from notation to develop vocal and instrumental skills.
- 3. Listen and respond to their own and others' music-making, thinking about, talking about and discussing a variety of characteristics within music that they create, perform or listen to.
